Subject: Award of Request for Tender - T-28-2023

Supply and Delivery of One Two-Wheel-Drive Three-Quarter

Ton Pickup Truck

BACKGROUND:

As per the County of Middlesex Five Year Machinery Replacement Program County staff are recommending the replacement of T-28, a two-wheel-drive three-quarter ton pickup truck.

This vehicle was originally Tendered in Fall 2022 with an anticipated 2023 delivery but the manufacturer ended up cancelling the order due to a lack of supply.

ANALYSIS:

A Request for Tender (RFT) was issued on October 11, 2023, which closed on October 26, 2023 with three submissions being received.

All three submissions were reviewed by County staff and deemed to meet the RFT's specifications for the vehicles.

Oxford Dodge Chrysler (1992) Ltd. was the low Tenderer at \$76,987.00 excluding H.S.T. A summary of the RFT results can be found attached to this report.

Delivery of the vehicle is expected to be immediately upon award.

FINANCIAL IMPLICATIONS:

The original estimated cost from 2021 of the vehicle prior to Tendering was \$65,000.00 excluding HST with the previously awarded Tender in 2022 being \$72,400.00 excluding HST, which was included within the 2023 budget. As this vehicle is being delivered

immediately following the award of this Tender, the additional cost will be taken from the undelivered T-33.
