Subject: Tender for Concrete Curb and Gutter Contract M-F-24

BACKGROUND:

Contract M-F-24 for the supply of Concrete Curb and Gutter was advertised with tenders accepted until 12 noon, Wednesday, February 21, 2024.



ANALYSIS:

The County received six bids for this contract. Due to concerns with capacity to complete the contract work on the low bid, Middlesex County will be taking the second lowest bid by Ro-Buck Construction Ltd for the contract with a total bid price of \$289,839.50 plus HST. A summary of the total bid prices is attached.

Ro-Buck Construction have worked for the County in the past and have provided service and product that meets or exceeds the expectations of the County. It is recommended that their bid be accepted.
