Subject: Tender for Cold in Place Asphalt Recycling Contract M-C-24

### **BACKGROUND:**

Contract M-C-24 for the supply of hot mix asphalt was advertised with tenders accepted until 12 noon, Thursday, February 22, 2024.

## **ANALYSIS:**

The County received three bids for this contract. Lavis Contracting Co. Limited was the low bidder with a total bid price of \$1,328,520.00 plus HST. A summary of the total bid prices is attached.

Lavis Contracting Co. Limited have worked for the County in the past and have provided service that meets or exceeds the expectations of the County. It is recommended that their bid be accepted.
