## **BACKGROUND:**

Contract M-B-24 for the supply of hot mix asphalt was advertised with tenders accepted until 12 noon, Thursday, February 22, 2024.



## **ANALYSIS:**

The County received four bids for this contract. Brantco Construction. was the low bidder for the contract with a total bid price of \$5,883,805.80 plus HST. A summary of the total bid prices is attached.

Brantco Construction has not worked with Middlesex County in the past but their references in neighbouring Municipalities are good. It is recommended that their bid be accepted.
