Subject: Tender for Supply and Installation of Sub Drains Contract

### **BACKGROUND:**

Contract M-E-24 for the supply of supply of Sub Drains was advertised with tenders accepted until 12 noon, Thursday, February 22, 2024.

### ANALYSIS:

Contract M-E-24 is for the supply and installation of sub drains on County Roads in order to improve drainage on County Road 16 and County Road 73 that will be paved during the 2024 construction season.

The County received two bids for this contact. The lowest bid in the amount of \$86,100.00 plus HST was submitted by Van Bree Drainage. This contractor has completed this type of work for the County in the past and has met or exceeded expectations. A summary of the total bid prices is attached.
