Subject:	Tender for Latex Traffic Paint Contract M-P-24

## BACKGROUND:

Contract M-P-24 for the supply of supply of Latex Paint was advertised with tenders accepted until 12 noon, Thursday, February 22, 2024.

## ANALYSIS:

This was a joint purchase for Middlesex and surrounding Municipalities. We received one bid for this contract from Sherwin Williams Paint with a total bid price of \$2,998,670.80 plus HST over a 2 year term. Middlesex County portion of the contract is \$703,700.00 plus HST over a 2 year term A summary of the bid totals is attached.

Sherwin Williams Paint have worked for the County in the past and have provided service and product that meets or exceeds the expectations of the County. It is recommended that their bid be accepted.
