Subject:	County Road and Bridge Assumption Study Committee

BACKGROUND:

The County of Middlesex assesses the needs of local municipalities for roads to be assumed by the County every five years through the County Road Assumption Study. The next set of roads are due for assumption in July of 2025. Bridges located on local roads will also be included in the analysis.

ANALYSIS:

Typically, the roads being considered for assumption by the County are evaluated by a committee made up of County councillors and local road supervisors. This committee is normally struck about a year before the roads are scheduled for assumption.

It is anticipated that there will be three committee meetings, one to set the parameters for road and bridge assumptions, a second to review the list of infrastructure to be considered and a final meeting to finalize the report before presentation to County Council for approval. Three local road officials and two County councillors plus the Warden are required to fill the committee.

The Warden and the County Engineer are recommending the following as members of this ad-hoc committee:
