1. CALL TO ORDER AND WARDEN'S REMARKS

Warden DeViet called the meeting to order at 1:02pm and addressed Council as follows:

We acknowledge that the land we stand upon today is the traditional territory of the Attawandaron (Add-a-won-da-run), Anishinabeg (Ah-nish-in-a-beg), Haudenosaunee (Hoden-oh-show-nee), and Lunaapeewak (Len-ahpay-wuk) peoples who have long standing relationships to the land, water and region of Southwestern Ontario. The local First Nation communities of this area include Chippewas of the Thames First Nation, Oneida Nation of the Thames First Nation, and Munsee-Delaware Nation.

We acknowledge the treaties that are specific to this area: Treaty 2 (McKee Purchase), Treaty 3 (Between the Lakes Purchase), Treaty 6 (London Township Purchase), Treaty 21 (Long Woods Purchase) and Treaty 29 (Huron Tract Purchase). We value the significant contributions, both in the past and the present of local and regional first nations of Turtle Island.

We acknowledge historic and ongoing injustices that indigenous peoples endure in Canada and we affirm our commitment to honouring indigenous voices, nations and cultures, and to moving forward in the spirit of reconciliation and respect.

This week is National AccessAbility Week and this year's theme is "Forward Together: Accessibility and Inclusion for All," which encourages us to unite our efforts in making Middlesex County, and all of Canada, a barrier-free place for everyone. Let's continue working together to promote accessibility and inclusivity in our community! Red Shirt Day of Action for AccessAbility and Inclusion is tomorrow Wednesday, May 29. On this day, I encourage everyone to wear red to show support for individuals with disabilities and their families, celebrate their achievements, and pledge to help create a fully accessible and inclusive society.

It is my great honour to mention and recognize some of our staff members.

Yesterday, the Honourable Edith Dumont, Lieutenant Governor of Ontario, and the Honourable Sylvia Jones, Deputy Premier and Minister of Health, presented medals to 11 paramedics, one of whom, David Jeffries, is a paramedic from the Middlesex-London Paramedic Service (MLPS). On August 14, 2019, Paramedic David Jeffries and his partner responded to a call after a vehicle crashed into a home. At the scene, a damaged gas line quickly ignited causing a massive explosion, destroying several homes, and injuring almost everyone present. Despite the fiery, debris-filled scene, Paramedic Jeffries stayed cool under pressure to triage, treat, and transport the police and fire personnel injured from the blast. As a result of their heroic actions, all six first responders and one civilian received medical attention for their injuries and survived. I want to extend my heartfelt congratulations to all the paramedics who received this prestigious award. Your courage and commitment to serving our communities are truly inspiring. The stories of bravery we're celebrating today are a testament to their heroic actions. I would like to especially congratulate Paramedic David Jeffries of the Middlesex-London Paramedic Service, your work not only saves lives but also brings hope to those in their darkest moments.

At a recent workshop hosted in Niagara-on-the-Lake, OMAA was pleased to honour Mr. Bill Rayburn with a long service recognition award, recognizing 30 years of service and acknowledging his hard work and dedication to the profession of CAO in Ontario.
