Subject: Award of Request for Proposal # ENG-2024-01: Engineering

Services for the Komoka Rd. Bridge Rehabilitation

BACKGROUND:

The Corporation of the County of Middlesex (the "County") has jurisdiction over a bridge known locally as the Komoka Road bridge located on Komoka Rd. southeast of Egremont Drive over the Sydenham River. The bridge deck, joints and walls were repaired by the County of Middlesex in 2015 and now requires repairs to the support structure including steel repair, blasting and recoating of structural steel, and replacement of the bridge bearing system.

The County was required to seek proposals from qualified firms to design a rehabilitation program and provide contract administration functions including tendering specifications/requirements and project management for the rehabilitation of Komoka Road bridge.

ANALYSIS:

A Request for Proposal (RFP) was issued on September 11, 2024 and closed on October 9, 2024 with the County receiving seven (7) submissions from the following Respondents:

Evaluations were conducted by both the County Engineer and Procurement Services. Respondents were evaluated on several components including organizational experience and qualifications, the project plan, and pricing.

Following completion of the evaluation process, it was determined that the Proposal submitted by Dillon Consulting Limited best met the objectives and requirements set forth in the RFP and demonstrated exceptional competency for the required services.

FINANCIAL IMPLICATIONS:

The proposed price by Dillon Consulting Limited for the services required in this proposal is \$109,600.00 excluding H.S.T. The costs for this project will be included in the 2025 Capital Budget.
