Subject: Award of RFP # ADMN-2024-03 – Consulting Services for the County of Middlesex Strategic Plan

#### BACKGROUND:

On September 10, 2024, the Council of Middlesex County passed the following resolution:

**THAT** the <u>Middlesex County Strategic Plan Report</u> be received for information;

**AND THAT** County Council direct staff to proceed with Strategic Plan development planning utilizing Option B - Development by a combination of internal staff and external consultants.

#### ANALYSIS:

Following Council's direction, County staff prepared and issued a Request for Proposal (RFP) for the aforementioned consulting services on September 16, 2024, closing on October 16, 2024 with the County receiving sixteen (16) submissions.

Evaluations were conducted by the County Engineer/Deputy CAO, County Treasurer/Deputy CAO, General Manager of Strategic Initiatives & Innovations, and the Procurement Services Manager with proposals being graded on the following criteria:

- Experience and Qualifications An overview of the organization, staff assigned to the County for the project, methodology and overall experience in performing Strategic Plans, and examples of past work.
- Project Plan Identifying timelines as to which they will be completing the Strategic Plan utilizing the proposed approach of the respondent.
- Proposal Pricing

At the conclusion of the evaluation process the Proposal from Quarry Consulting Inc. received the highest evaluation score as they demonstrated their organization's experience in conducting Strategic Plans for entities such as the County of Renfrew,

Township of Arnprior, Township of Douro-Dummer and London Hydro at a competitive cost.

Quarry Consulting's approach to complete the County Strategic Plan will involve interviews and engagement sessions with both County Council and senior staff as well as engagement of local municipalities, business and industry associations, community groups and local Indigenous community members through a combination of focus groups and surveys.

If awarded, the project will commence immediately upon contract execution with the anticipated completion of the final Strategic Plan being presented to County Council by Spring 2025.

A summary of the Respondents is attached hereto as Appendix 'A'.

# FINANCIAL IMPLICATIONS:

The Proposal from Quarry Consulting total is \$28,900.00 excluding HST. Funding for these services will be from Tax Rate Stabilization (Surplus).
