Subject:	Middlesex County Warden's Activity Report	

BACKGROUND:

The Municipal Act, 2001, generally outlines the role of Warden to:

- Act as chief executive officer of the municipality;
- Preside over council meetings;
- Provide leadership to the council;
- Represent the municipality at official functions; and,
- Carry out the duties of the head of council under this or any other Act.

The purpose of the Warden's Activity Report is to formally provide an overview of the Warden's government and community relations activities, achievements, projects and engagements on behalf of Middlesex County.

During this reporting period, the Warden's activities consisted of a mix of political, community, and internal organizational engagements. These activities included meetings with elected representatives and various levels of governance and participation in events such as the Strathroy Christmas Parade, the Ministry of Long-Term Care funding announcement of the expansion of diagnostic services in Middlesex County and London Long-Term Care Homes through the CPLTC+ Program and touring the new Ontario Plants Propagation Limited facility in Glencoe. The schedule also includes regular communication and planning meetings internally with the County staff, the CAO, and different committees.
