**NOTICE OF PROJECT COMMENCEMENT**

The Municipality of Southwest Middlesex is developing the Glencoe Industrial Park located on the south side of Industrial Drive in the community of Glencoe, Range 2 NLR Part Lot 24. The objective is to design and construct a new municipal road, watermains, sanitary sewers, storm sewers and a stormwater management facility needed to service industrial development within the project area. The proposed new road will extend from Industrial Road approximately 340 metres to a turn-around circle. This road is intended to serve industrial lots within the project area. The land within the Class EA project area is owned by the Municipality.

The planning for this project is following the environmental screening process set out for Schedule B activities under the Municipal Class Environmental Assessment (Class EA) document. The purpose of the screening process is to identify any potential environmental impacts associated with the project and to plan for appropriate mitigation of any impacts. The process includes consultation with the public, stakeholders, and government review agencies. The proposed project is being planned under Schedule B of the Municipal Class Environmental Assessment (Class EA).

**PUBLIC INVOLVEMENT:**

The consultation program for this Class EA includes several opportunities for public involvement. For the initial phase of the program, public input will be received until July 18, 2025.

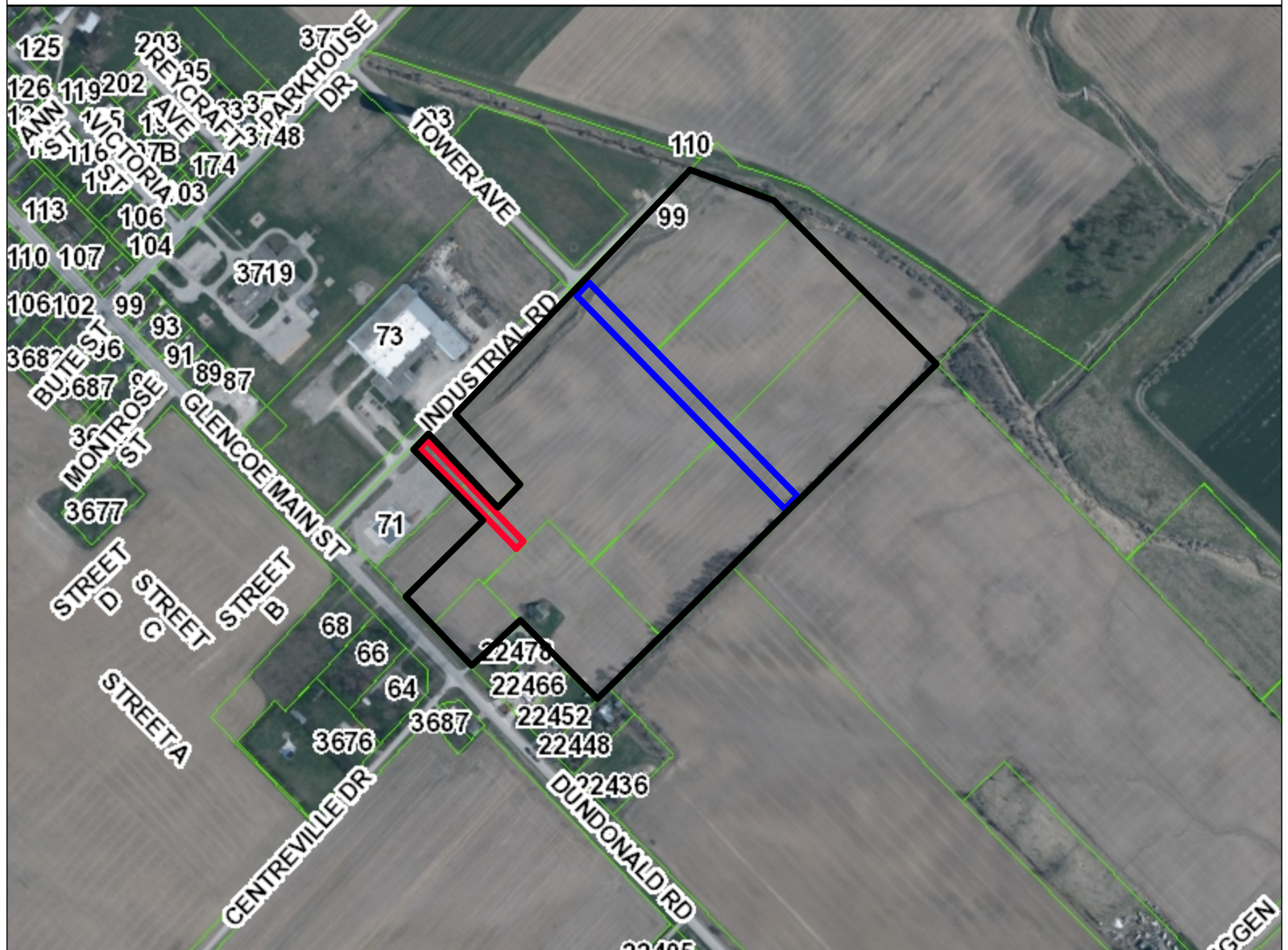
