Subject: Middlesex Supports 2025-2026

BACKGROUND:

From 1999 to 2008, funds clawed back from the National Child Benefit Supplement (NCBS) on Ontario Works (OW) cheques were redirected to support a variety of local programs for children in Middlesex County. The core goals of this NCBS reinvestment strategy were to reduce the depth of child poverty and support parental reattachment to the workforce.

In 2009, the Province stopped deducting the NCBS from client cheques and introduced the Ontario Child Benefit (OCB). This policy change shifted funding for children's basic needs from the OW cheque to the OCB, generating substantial municipal savings — approximately \$112,000 annually for Middlesex County. Municipalities were directed to reinvest these savings into community programs aligned with the original intent of the NCBS strategy. Since then, the program has been renewed annually through the budget process and has evolved over time, with updates to funded initiatives.

All current programs were approved in the 2025 budget, and contracts for subsidized services concluded on March 31, 2024

ANALYSIS:

Middlesex County continues to receive funding requests from six core community partners participating in the Middlesex Supports Program.

Attached is a summary of each program, including requested funding, the number of children and families served in 2024–2025, and projections for the upcoming fiscal year ending March 31, 2026. Collectively, these programs served 96 children and 255 families in the 2024–2025 period. Each initiative continues to address service gaps for young residents with measurable success in delivery and outcomes.

The total funding requested for 2025–2026 is \$96,900 — already approved in the 2025 Social Services budget. All funded partners are required to report on outcomes.

Funding will only be disbursed once program operation is confirmed and verified to be serving Middlesex County residents. In keeping with past practice, funding may be adjusted based on program start dates or interruptions in service.

In 2024–2025, \$6,336 in approved funding was not allocated due to valid circumstances beyond the control of the service providers. Recognizing the value of sports and recreation for child and youth development, it is recommended that this unallocated amount be distributed equally among Middlesex County's eight lower-tier municipalities to support access to recreation and sport programs for children and youth.

2025-2026 projected number served and funding allotments are as follows:

RECOMMENDATION:

THAT the Middlesex Supports 2025-2026 report be received for information;

THAT County Council approve the allocation of the unspent \$6,336.00 to be divided evenly (\$792.00 per municipality) among the eight lower-tier Middlesex County municipalities, to support children and youth in accessing sports and recreation opportunities.

AND THAT the General Manager of Finance and Community Services be authorized to execute, on behalf of the County of Middlesex, all agreements and other documents necessary to allocate the remaining funding as described in the Middlesex Supports 2025-2026 Report on confirmation that such agreements and other documents be in a form satisfactory to the County Solicitor.
