Subject:	Middlesex County Warden's Activity Report – Q2

BACKGROUND:

The Municipal Act, 2001, generally outlines the role of Warden to:

- Act as chief executive officer of the municipality;
- Preside over council meetings;
- Provide leadership to the council;
- Represent the municipality at official functions; and,
- Carry out the duties of the head of council under this or any other Act.

The purpose of the Warden's Activity Report is to formally provide an overview of the Warden's government and community relations activities, achievements, projects and engagements on behalf of Middlesex County.

During this reporting period, the Warden's activities consisted of a mix of political, community, and internal organizational engagements. These activities included meetings with elected representatives and various levels of governance and participation in events, such as the Western Ontario Wardens' Caucus Meeting, Middlesex-London Health Unit/County of Middlesex Touchbase and LDCSB Planning Collaboration Meeting. These activities provided important opportunities to advance Middlesex County's interests on topics such as health care, education, and regional economic development. The schedule also includes regular communication and planning meetings internally with the County staff, the Interim CAO, and different committees.

Warden Ropp met with the Honourable Rob Flack, Minister of Municipal Affairs and Housing, to discuss a range of important issues including community transportation and rural mobility, land use planning and Ontario Land Tribunal reform, local housing leadership initiatives, the Housing Accelerator Fund, the Housing Advocate position, coordination with the Consolidated Municipal Service Manager (CMSM), and proposed legislative changes under Bill 17 (Protect Ontario by Building Faster and Smarter Act, 2025).

The Warden's schedule also incorporated commitment to local partnerships and public engagement. Highlights included Middlesex Municipal Day hosted by Strathroy-Caradoc, the Tourism Symposium at the Lucan Community Centre, the Strathroy & District Chamber of Commerce Awards, and the Warden's Charity Golf Tournament.

The activities of the Warden are conducted in accordance with the broad direction of Council and in alignment with the Middlesex County Strategic Plan and its Guiding Principles:
