THE CORPORATION OF THE COUNTY OF MIDDLESEX

BY-LAW #7194

A BY-LAW to amend the enforcement provisions of Parking By-law #6208

WHEREAS:

- **A.** Section 11(3) of the *Municipal Act* provides that a municipality may pass by-laws respecting highways under its jurisdiction;
- **B.** The Council for the Corporation of the County of Middlesex enacted By-law #6208 to regulate the parking of motor vehicles on County highways; and
- **C.** The Council of the Corporation of the County of Middlesex deems it necessary and desirable to amend the enforcement provisions of Parking By-law #6208.

NOW THEREFORE the Council of The Corporation of the County of Middlesex enacts as follows:

- 1. The above recitals are true and hereby incorporated into this By-law by reference.
- 2. The provisions of Parking By-law #6208, which is attached hereto as *APPENDIX "A"* and forms a part of this Amending By-law #7194 are incorporated *mutatis mutandis* into this by-law. Parking By-law #6208 shall continue in full force, subject to the changes herein.
- 3. The definition of "municipality" in section 1 of Parking By-law #6208 is hereby deleted in its entirety and replaced with the following definitions:

"County" means the Corporation of the County of Middlesex;

"Local Municipality" means any one or more of the following: The Corporation of the Township of Adelaide-Metcalfe; The Corporation of the Township of Lucan Biddulph; The Corporation of the Municipality of Middlesex Centre; The Corporation of the Municipality of North Middlesex; The Corporation of the Municipality of Southwest Middlesex; The Corporation of the Municipality of Strathroy-Caradoc; The Corporation of the Municipality of Thames Centre; and The Corporation of the Village of Newbury; and

"municipality" means a municipality, as defined by the *Municipal Act*, 2001, S.O. 2001, c. 25, as amended or replaced.

4. The definition of "By-law Enforcement Officer" in section 1 of Parking By-law #6208 is hereby deleted in its entirety and replaced with the following:

"Municipal Law Enforcement Officer" means:

- i. a by-law enforcement officer appointed by the County or a Local Municipality, whose responsibilities include the enforcement of this By-law.
- ii. the County Engineer;
- iii. a police officer; and
- iv. any other officer, employee or agent of any municipality or any local board of any municipality whose responsibilities includes the enforcement of this By-law;

each of which are provincial offences officers, as defined in the *Provincial Offences Act*, R.S.O. 1990, c. P.33, as amended or replaced.

5. Where there is any reference to legislation or a by-law within By-law #6208, as amended, the reference to such legislation or by-law shall be interpreted to mean the legislation or by-law, as amended or replaced.
