Subject: External Audit Services

BACKGROUND:

KPMG has provided external audit services for the County of Middlesex, County of Middlesex Trust Funds, County Library Board, Middlesex London Emergency Medical Services Authority and Strathmere Lodge Long-term Care Annual Report since 2007. The term is coming to a conclusion.

ANALYSIS

KPMG is a Canadian leader in delivering Audit, Tax, and Advisory services and are able to provide a combination of professional integrity, independence, and ethical behaviour, underpinned by rigorous quality control procedures. KPMG has significant professional presence in Southwestern Ontario and the largest municipality audit market share across Canada.

KPMG has provided high quality and value-added service. Over the past few years, we have utilized their expertise for income tax information, asset valuation, sale of buildings and special projects such as EMS expense cut off and EarlyON Child and Family Centre Provincial Capital Funding. They inform us of regulatory updates, publications tailored to public sector issues and offer relevant webinar sessions such as Forensic Services and Fraud Awareness. In the proposal, KPMG is also offering 5 registrations for Middlesex CPAs to attend the KPMG Learning Academy and select courses of interest.
