# The New Normal



"In Canada, yearly insured catastrophic losses has reached \$2 billion" – a significant increase from the \$422 million per year between 1983 and 2008" Canadian Underwriter, August 23, 2022

8 of the top 10 highest loss years on record occurred in the last decade.



# LEGAL LANDSCAPE SOCIAL INFLATION

- LITIGIOUS SOCIETAL ATTITUDE
- **LEGAL REPRESENTATION** (A recent study by The Financial Services of Commission of Ontario has found that 91% of claimants in motor vehicle accident claims have some form of legal representation)
- **CONTRIBUTORY NEGLIGENCE**



## THE COUNTY'S INSURANCE PROGRAM

#### **GENERAL LIABILITY**

LIMIT: \$15,000,000

Deductible: \$25,000

Defends the County's actions and/or pays damages if the County is "negligent" re: injury to the public and/or damage to public property arising from County services or from County assets e.g., buildings; parks, pool, arena, unlicensed equipment



# **GENERAL LIABILITY (continued)**

- No General Aggregate
- Includes Products (like Water)
- Includes professional exposures like engineering staff or building inspection services

Insures: "CORPORATION OF THE COUNTY OF MIDDLESEX AND MIDDLESEX COUNTY LIBRARY BOARD"



# **GENERAL LIABILITY (continued)**

- BOARDS, COMMISSIONS, COMMITTEES OF COUNCIL AND THEIR MEMBERS
- STATUTORY OFFICERS / OFFICERS
- FIREFIGHTERS
- FMPI OYFFS
- VOLUNTEERS

#### **INCLUDES:**

 WRONGFUL DISMISSAL (Legal **Expense**)

\$250,000 at ONE claim \$250,000 annual aggregate \$ 5,000 deductible each claim



## **ERRORS & OMISSIONS LIABILITY**

MUNICIPALITIES CAN BE SUED RE: INFORMATION GIVEN IN ANSWER

TO PUBLIC QUERIES, E.G.:

- ZONING
- PLANNING
- BUILDING INSPECTION

COMPENSATORY

DAMAGES

DAMAGES FOR **ECONOMIC** LOSS



## **ERRORS & OMISSIONS LIABILITY (CONT'D)**

#### "Wrongful Acts" ...

- actual or alleged errors
- misstatements OR misleading statements
- omissions

in the performance of services usual to the County's operations

LIABILITY LIMIT: \$15,000,000

DEDUCTIBLE: \$ 10,000

CLAIMS MADE – RESPONDS TO CLAIMS OCCURRING AND REPORTED DURING POLICY TERM



## **NON-OWNED AUTOMOBILE LIABILITY**

Employers can be held responsible when vehicles are operated on their behalf (or under their direction) even though the employer neither owns nor operates those vehicles

addresses this 'vicarious liability'

 provides coverage for the County's short-term vehicle rental

LIABILITY LIMIT: \$ 15,000,000

LEGAL LIABILITY FOR DAMAGE TO HIRED VEHICLES: \$ 250,000

**DEDUCTIBLE:** 500

RENTAL PERIOD: **MAXIMUM** 30 DAYS



## **EXCESS LIABILITY**

#### LIMIT OF LIABILITY:

\$10,000,000

ACHIEVES A TOTAL LIMIT OF LIABILITY OF \$25,000,000

#### UNDERLYING POLICY / LIMIT

General Liability \$ 15,000,000

• E & O Liability 15,000,000

Non-Owned Auto 15,000,000

• Auto Fleet 15,000,000



## **ENVIRONMENTAL LIABILITY**

Pollution incidents threaten public health and the environment.

Municipal exposures:

- retention ponds
- construction sites
- underground fuel storage
- winter maintenance
- marinas
- fire-fighting chemicals

LIABILITY LIMIT: \$ 1,000,000

ANNUAL AGGREGATE: \$ 2,000,000

DEDUCTIBLE: \$ 10,000

CLAIMS MADE – RESPONDS TO CLAIMS FIRST MADE AGAINST THE CONTY DURING THE POLICY PERIOD **AND** FOR WHICH THE COUNTY HAD NO PRIOR KNOWLEDGE



## **CRIME**

EMPLOYEE DISHONESTY

(Internal fraud-includes theft of property) \$ 1,000,000

LOSS OF MONEY & SECURITIES 300,000

MONEY ORDERS & COUNTERFEIT CURRENCY 200,000

AUDIT EXPENSE 200,000

DEPOSITOR'S FORGERY 1,000,000

COMPUTER / TRANSFER FRAUD 200,000



## **ACCIDENT**

ACCIDENTAL DEATH & DISMEMBERMENT	\$ 250,000
PARALYSIS	500,000
WEEKLY INCOME - TOTAL DISABILITY	500
WEEKLY INCOME - PARTIAL DISABILITY	300
ACCIDENTAL DEATH OF SPOUSE WHILE	
TRAVELLING ON COUNCIL BUSINESS	INCLUDED
24 HOUR COVERAGE	INCLUDED

- Coverage up to and including age 80
- Aggregate limit: \$2,500,000 accident involving more than one councillor



## **LEGAL EXPENSE**

Covers councillors, board members, directors, officers, employees & volunteers while engaged in County's duties

CLAIMS MADE – immediate report and within policy term)

LEGAL DEFENCE \$100,000

**ANNUAL AGGREGATE** \$500,000

Legal expenses in defending:

- alleged criminal offence
- Investigation or charge levied under an ON Regulation or Statute (including Human Rights Tribunals)

 EXCLUDES: Highway Traffic Act and Conflict of Interest Act



## **PROPERTY**

- County buildings, contents, equipment
- Protects revenue from income generating facilities
- ALL RISK / REPLACEMENT COST

**DEDUCTIBLE:** \$ 10,000

**LIMIT:** OVER \$87,700,000

#### **INCLUDES:**

- Building Bylaws
- Debris Removal
- Pollution cleanup up to \$1,500,000
- Inflation adjustment
- Our own inspection team conducts site visits and establishes values for insurance



## **EQUIPMENT BREAKDOWN**

Works in tandem with the Property policy to respond to "breakdown" of equipment under pressure or types of mechanical, electrical or pressure equipment than can malfunction and cause property damage as well as revenue loss e.g. arena equipment.

**INCLUDES:** Inspection services for boilers and pressure vessels to satisfy the TSSA requirements.

DAMAGE LIMIT:

**DEDUCTIBLE**:

\$ 50,000,000 PER ACCIDENT

\$ 10,000



## OWNED AUTOMOBILE / FLEET

PROVIDES MANDATORY AUTO INSURANCE FOR THE COUNTY'S'S LICENSED OWNED & LEASED VEHICLES AND TRAILERS

THIRD PARTY LIABILITY: \$ 15,000,000

STATUTORY ACCIDENT BENEFITS

DIRECT COMPENSATION PROPERTY **DEDUCTIBLE \$10.000** DAMAGE

PHYSICAL DAMAGE (Replacement Cost; Valued; Actual Cash Value recovery) **DEDUCTIBLE \$10,000**
