Thank you for sharing your priorities when we met. I would also like to take this opportunity to commend SCOR's efforts to work with various organizations on the development of projects that support the agriculture industry in Ontario.

Our government maintains a high level of support for rural Ontario's growth through projects that aim to attract local investments, create jobs and boost economic development. Through the Rural Economic Development Program, since September 2019, \$11.4 million has been committed to over 220 economic development projects. I was very interested to learn of SCORs collaborations with Conestoga and Fanshawe Colleges to fill skills gaps and provide condensed training. This initiative to create a program that allows for on-farm experience while training is integral to building up the next generation of farmers.
