- *** when the MCBSO acts for a local municipality, it is that municipality's corporate and/or litigation counsel**
- * appropriate professional firewalls in place in accordance with Law Society rules
- no reporting to the County Municipal Corporation on local particulars
- ♦ report directly to local Council and CAO

not "County Legal", please

- ♦ so please refer to us as "MCBSO" and not "County Legal"
- ♦ in legal proceeding filings and court documents, it has been necessary to differentiate the Firm from the County when it is acting for a local municipality:

- County's first extensive hybrid work model test
- Non-union, unique type of environment
- Office has been remote since 2012, subject to being in Middlesex/London for meetings and court, as required
- Long before COVID
- Clients e-mail or call for advice first, then set up meetings
- Has allowed for tremendous efficiency and work product
- Multiple Council meetings a day possible
- Post COVID, even the Courts and Tribunals (Court of Appeal, Superior Court POA Court keeping a hybrid model (virtual for all appearances, motions and hearings which are not trials)
- Has increased access to quality legal advice and justice
- Provides for work/life balance

Value Added Service

- ***** the most underlooked but most valuable service that we offer
- having Legal Services Available at affordable cost often BEFORE the matter becomes an absolute legal emergency
- **⋄** problems fixed at the root = LITIGATION AVOIDANCE
- example: Not fully understanding statutory responsibilities and not having appropriate responsibility, indemnity and security provisions is one of the primary causes of litigation and liability
- ♦ don't wait too long when concerns arise...come early

MCBSO INSURANCE CLAIM PROCESS EXPLAINED



MCBSO Insurance Claim Work Explained

- ♦ Claims/Litigation under Deductible: Handled in-house by MCBSO Directly
 - ♦ i.e. MVA claims, road damage claims, road allowance work claims, etc.
- **⋄** Claims/Litigation above Deductible: = MCBSO Process
 - **MCBSO Process Applies**
- **MCBSO Claims Above Deductible Process:**
 - **♦ A Legal Process**
 - **⋄** Commenced in 2017 at County and has led to major success
 - **♦ Insurer confirms**

MCBSO Claims Above Deductible Process

- ♦ Receives Served Documents for the County, from Clerk/Department Heads
- **Determines if it is an initiating process (Statement of Claim) or just a notice of potential claim (Notice)**
- ♦ Determines if there is jurisdiction for the claim to be made
- ♦ If no jurisdiction or bogus claim, ELIMINATES CLAIMS by dealing with claimant directly or making Motion in Court to knock them out
 - ♦ we call this "active municipal management of claims"

MCBSO Insurance Process cont...

- ♦ Provide a legal opinion on the merits of the claim and on best strategy to defend
- ♦ Should insurer assign insurance Council, we work as co-counsel with the assigned insurance Council to ensure they know the intricacies of Municipal and not just MVA litigation, do not settle on points that the County does not want to settle on, and forward the defence of the Claim the way the County wants and not necessarily how the insurer wants
- ♦ Must municipalities use this process? No
- ♦ It is it necessary they do this? Yes. Otherwise, claims do not get forwarded with municipal expertise and are settled at time and at rates the Municipality does not want.
- **MCBSO** has worked with the insurer at the County level to allow the County to have that influence and on occasion, we have expended this to local municipalities where they have retained us on it

MCBSO Insurance Process Result

- **♦ 2017: Many more claims than we have now**
- **⋄** Impacts premium and deductible
- **MCBSO's claims process has caused claims to be reduced every year since 2017**
- **The Example 2023: Much fewer open claims and reserves**
- **♦ May 2023: Minuscule open claims and reserves**
- **♦ Had claims remained same as in 2017, municipality would be paying approximately 40% higher premiums**

MCBSO Insurance Process Result

- ♦ = Gets the municipality a low deductible and premium credits
- **⋄** Middlesex County = lowest deducible of ANY municipality in Ontario
- **⋄** This at a time of increasingly litigious societal attitude
- **The Expertise Staff and consultants without the necessary legal expertise do not have the expertise to shrink claims by years**
- ♦ 91% of those who forward a claim have legal representation

If no MCBSO process...

- **The expertise and are settled at time and at rates the municipality does not want. It is too easy just to just give to a broker or insurer and tack on a reserve, which only increases reserves, deductibles, and premiums**
- **MCBSO** has worked with the insurer to allow the County to have that influence
- ♦ The MCBSO can work with your insurer or broker as well (flat fee discussions available)
