Subject: The Middlesex Initiative: Breaking New Ground – 2021-2024

Strategic Plan

#### **BACKGROUND:**

The Middlesex Initiative: Breaking New Ground represents a robust strategic plan to guide the development and operations of Middlesex County for the 2021-2024 period. Developed through a comprehensive process initiated by Middlesex County Council in early 2020, the strategic plan charts out a vision, guiding principles, goals and objectives focusing on legislated core service areas. By fostering collaboration, guiding resource allocation, and promoting long-term sustainability, the plan is designed to ensure that Middlesex County is optimally positioned to leverage future opportunities in line with the evolving needs and aspirations of its communities.

This forward-looking strategic plan encapsulates key focus areas like Innovation & Readiness, Modernization, Collaboration & Readiness, Responsiveness & Resilience, and Vision & Leadership, all of which align with the defined guiding principles. Through specific objectives within the strategic focus areas of Cultivating Community Vitality, Connecting Through Infrastructure, Strengthening Our Economy, and Promoting Service Excellence, the plan not only sets the County on a path towards sustainable development but also assures accountability and transparency. The plan's development and implementation journey involved a series of discussions, revisions, breakout sessions, and partnerships, which ultimately led to its approval on January 19, 2021. As Middlesex County progresses through this strategic plan, the focus remains on legislated core services, with planning for the next strategic plan set to begin in 2024.

# What is a Strategic Plan?

A strategic plan is a tool for setting the direction and making informed decisions for the County's future. It is a critical resource that helps municipalities navigate changes, tackle

challenges, and seize opportunities. The Middlesex Initiative serves several important purposes in guiding the development and operations of the County including:

- The plan articulates a vision for the future of the County, based on a shared understanding of the County's values, aspirations, and priorities.
- The plan defines clear, actionable goals and objectives that align with the vision.
  These goals may relate to a wide variety of municipal issues, such as economic
  development, land use, infrastructure, public safety, environment, and social
  services.
- The plan guides the allocation of resources, assisting Council to prioritize investments and initiatives that will have the greatest positive impact on the County.
- The plan provides a framework for developing and implementing County policies and procedures.
- The plan can help foster collaboration and build partnerships among various stakeholders, including service areas, residents, businesses, non-profit organizations, and other government entities.
- The plan provides a basis for measuring performance and progress towards goals, fostering accountability among municipal leaders and transparency to the public.
- The plan encourages a long-term view, promoting sustainable decision-making that balances current needs with the future wellbeing of the County.

The Middlesex Initiative generally establishes a clear direction and focus on core legislated services and infrastructure for the County for the four year period of 2021 to 2024. As the community is constantly growing and changing, the strategic plan ensures that Middlesex County is well positioned to respond to challenges and capitalize on future opportunities that arise.

#### The Process:

In January 2020, Middlesex County Council began to consider the development of a strategic plan and the process in which to use to achieve the development of the strategic plan.

On February 18, 2020, County Council received a presentation from staff outlining the proposed goals to be achieved through the strategic planning process as well as a strategy to accomplish them. During this presentation Council took the opportunity to refine the goals and to provide direction as to how to undertake the strategic planning process.

Throughout the month of June 2020, County Council and staff participated in a number of breakout sessions and working group meetings. Following the breakout sessions, the strategic planning working group developed the first draft version of the strategic plan for Council's review and consideration. Staff presented County Council with the draft version of the strategic plan on July 14, 2020. During this time, Council had significant and

thoughtful discussion in regard to the strategic priorities, goals, objectives and guiding principles. Through this discussion, County Council's final draft strategic plan was developed.

On October 13, 2020, County Council approved the Strategic Focus, Goals, Objectives and Guiding Principles that were developed through the strategic planning process.

On January 19, 2021 County Council approved the Middlesex County 2021 - 2024 Strategic Plan, the Middlesex Initiative: Breaking New Ground.

#### The Middlesex Initiative Overview:

Historically, the County has always been very good at strategically navigating internal and external environments by aligning administrative actions and resources with Council priorities. The Middlesex Initiative enhances these efforts through guiding principles:

### **Guiding Principles:**

- Balancing the rural-urban qualities of the County
- Building relationships and working in a collaborative and supportive way
- Leading through innovation, evaluation, and continuous improvement
- Recognizing the uniqueness of our local municipal partners
- Maintaining financial sustainability
- Focusing on diversity and inclusion
- Being flexible and responsive

Monitoring the progress of the strategic plan plays a pivotal role in the overall success of the strategic plan. It establishes a rigorous and systematic approach to ascertain the effective implementation and accomplishment of the established goals and objectives.

Further, by monitoring and tracking progress, Middlesex County can swiftly identify and address any issues that could impede the path towards the identified strategic goals. This proactive approach allows Middlesex County to recalibrate efforts in a timely manner and make necessary adjustments to strategies or resource allocations.


